- 3. There are criminal proceedings against our promoter and Group Companies which, if materialized may have adverse effect on the Company.
- 4. The shareholding of Promoter & Promoter Group in the Company is only 20.03%.
- 5. We, as an NBFC, have to adhere to several regulatory norms prescribed by RBI from time to time. Any noncompliance with such norms or any adverse change in the norms could negatively affect our Company's operations, business, financial condition, and the trading price of Equity Shares.
